G.Edn - HSE-Estt- Shifting of HSSTs in **Geography** - Consequent on promotion / transfer and posting of Principals teaching the same subject - Orders issued.

**ORDER**

Vide the Government order read above, transfer and posting/promotion of principals were effected in various Government Higher Secondary schools. As the post of Principals in Higher Secondary schools are teaching posts, the teachers in the same subjects that of the principals became in excess than the sanctioned strength in the schools where the Principals are posted. At the same time the post fell vacant in the schools from which teachers were relieved on promotion/transfer as per the above Government order.

For the best interest of students and to avoid additional financial commitment to Government, the following HSSTs in **Geography** have to be shifted from the schools where they are working now as the subject taught by them is same as that of the Principals posted. Hence they are shifted and posted **with immediate effect** in the schools noted against their name. The posting status of those teachers who have completed five years of continuous service in the present district will be updated as "conditional" and that of all other teachers will be updated as "normal".

The teachers under orders of shifting as shown above have to be relieved of their duties only if the Principal teaching the same subject has taken charge.

The teacher under orders of shifting will be transferred to another school if a better claimant posted in the event of the General Transfer/Court order/Govt. orders.

The Principal concerned shall relieve the teachers **with immediate effect** and report the relieving/joining duty of the teachers. The status of the teachers should be strictly updated in the 'dhsetransfer' site as per the given instructions.
