ORDER

Vide the Government order read above, transfer and posting /promotion of principals were effected in various Government Higher Secondary schools. As the post of principals in Higher Secondary schools are teaching posts, the teachers in the same subjects that of the principals became in excess than the sanctioned strength where the principals are posted. At the same time the post fell vacant in the respective schools of the principals were working before the issuance of the above Government order.

For the best interest of students and to avoid additional financial commitment to Government, the following HSST **Mathematics** has to be shifted from the school where she is working now as the subject taught her is same as that of the Principal posted. Hence she is shifted and posted **with immediate effect** in the school noted against her name. The teacher is shifted and posted to the new school on 'normal status' as she has not completed three year Higher Secondary service in the district where she is working now.

ORDER

Vide the Government order read above, transfer and posting/promotion of principals were effected in various Government Higher Secondary schools. As the post of principals in Higher Secondary schools are teaching posts, the teachers in the same subjects as that of the principals became in excess than the sanctioned strength where the principals are posted. At the same time the post fell vacant in the respective schools of the principals were working after the issuance of the above Government order.

For the best interest of students and to avoid additional financial commitment to Government, the following HSST in **Mathematics** has to be shifted from the school where he is working now as the subject taught him is same as that of the Principal posted. Hence he is shifted and posted **with immediate effect** in the school noted against his name. The teacher under orders of shifting as shown above have to be relieved of his duties only if the Principal teaching the same subject has taken charge. The


