Kerala Road Safety Authority has approved a proposal HSS-CARE (Higher Secondary Students- Campaign for Assisting Road Safety Empowerment) submitted by Career Guidance and Adolescent Counseling Cell for conducting Road Safety Awareness campaign for Higher Secondary Students in Thiruvananthapuram, Alappuzha, Ernakulam and Thrissur Districts. Department and Kerala Road Safety Authority regard this programme with utmost importance which aims at creating awareness among adolescents to reduce road accidents. In the above districts the numbers of road accidents are alarmingly increasing, mostly among two wheelers driven by adolescents. Souhrida co-ordinators were given charge on the implementation of the programme and Principals of the selected schools were directed to depute the Souhrida Co-ordinators for the planning session scheduled to be conducted at district headquarters.

The circular of the programme was published in the DHSE portal well in advance and Sourhida Co-ordinators were contacted in person over telephone to remind them to attend the programme. In spite of all these efforts, Principals of 25 schools, without capturing the real spirit behind the venture, have discarded the directions from the Directorate and have not relieved the teachers for the training. The actions of the Principals are unfortunate and considered as insubordination.

Hence Principals of the 25 schools are directed to furnish explanation for not deputing Souhrida Co-ordinators for the programme and present in person along with the Souhrida Co-ordinators before the Director, Higher Secondary Education on **1<sup>st</sup> October 2014 at 11am**. Any failure from the part of Principals in this regard will be viewed seriously and warrant disciplinary action.
