Sub:- DGE –CG&AC-Student Centric Programme “**Karuthu**” Training on Self-Defense for Higher Secondary Girl Students-Application invited-reg

Ref: - GO (Rt) No./3151/2021 G.Edn Dated 26/06/2021

As part of students centric programme, Career Guidance and Adolescent Counseling Cell organizes a special programme **KARUTHU**, aiming for the development of physical, social and mental health of the girls students from 2013 onwards . For the year 2021-22, it is decided to conduct the Karuthu Programme in 70 Higher Secondary schools. The criteria for implementing the programme are noted as below.

1. Principal should select one item for training that comes under self-defense (Karate, Kunfu, Judo, Taekwondo, Kalaripayattu etc.)
2. The Principal should identify a qualified trainer. Preference should be given to female trainers.
3. The trainer should have the recognition from the District Association of the item concerned.
4. Training should be conducted on Saturdays and on other holidays.
5. In the case of Karate, Kerala Karate Association has agreed to provide training free of cost. Hence the fund for honorarium of the trainer will not be allotted by the Department.
6. Programme should be implemented in the schools in association with PTA. A female member of the PTA shall be present in the school premises during the training.
7. Fund for purchase of training materials, uniform, refreshment and honorarium to the trainer will be provided by the Department.
8. A teacher (HSST/ HSST (Jr)) should be selected as convenor for the implementation of the Programme in the school.

Principals of schools desirous of conducting Karuthu programme in 2019-20 should submit application in the prescribed form on or before **01/12/2021 4.PM** to the following address. **The schools who had conducted KARUTHU programme in the previous years also need to apply for the conduct of programme 2021-22**
