CIRCULAR

Sub: GAD-Observance of 'Constitution Day' on 26th November 2024 in all Educational Institutions, Government Departments and Public Sector Undertakings/Autonomous Bodies – Instructions issued - Regarding.

Government of India has notified 26 November as 'Constitution Day' to commemorate the adoption of the Constitution of India and to pay tribute to the invaluable contribution of Babasaheb Dr. B.R.Ambedkar and other founding fathers of the Constitution. Every Year as a part of the celebrations a number of activities aimed at highlighting and reiterating the values and principles enshrined in the Constitution are organized. In connection with the celebrations, Government of India has decided to read out 'Preamble to the Constitution' (as it exists today) in all Government offices, Educational Institutions, Autonomous bodies, Organizations, Local Self Government Institutions throughout the country on 26th November 2024 and to organize activities like Talks/Webinars by eminent citizens on Fundamental Duties etc.

In the above circumstances, all District Collectors, Heads of Departments and Chief Executives of Public Sector Undertakings/Autonomous Bodies are directed to arrange programme for observing 'Constitution Day' on 26th November 2024 (Tuesday) by reading out 'Preamble' to the Constitution at 11:00 a.m in all offices. All educational institutions are also directed to read out the 'Preamble' to the Constitution and the fundamental duties as enshrined in Article 51A of the constitution. A provision has also been made on MyGov portal to 'Read the Preamble' online and download a Certificate. It is further directed to conduct the activities such as webinars, debates, speeches, essays and quiz competitions on the constitution of India in connection with the observance of Constitution Day. Universities may have special talks on the constitution.
